

## **Exodus Travels Bike to Work BC Contest OFFICIAL RULES**

### **Entry:**

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** The “Exodus Travels Bike to Work BC Sweepstakes” starts at 12:00 am Eastern Time (“ET”) on October 1<sup>st</sup> and ends at 11:59 pm on November 15<sup>th</sup> (“The Promotion Period”). To be eligible to enter you must be a legal resident of Canada (excluding Quebec), at least 19 years of age or older as of November 15, 2019. **ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES. VOID IN QUEBEC AND WHERE PROHIBITED BY LAW.** Exempt are employees, partners, associates, and representatives of Exodus Travels Ltd. One (1) non-transferable grand prize, comprising of Exodus’ Cycling in Sicily (<https://www.exodustravels.com/italy-holidays/cycling/cycling-sicily/mwy?flights=excluded>) for 2 people, one winner with guest as selected by the Winner with the Sponsor’s sole discretion, guide, transfers, lunches, breakfasts and dinners included as stated per each day as in the tour itinerary featuring double occupancy standard hotel room with an approximate retail value, based upon high season pricing (“ARV”) of up to approximately \$4,550 CAD total will be awarded. Provided that the Winner completes international airfare bookings applicable to the trip through the Sponsor’s air services department, then the Sponsor shall contribute up to \$1,200 CAD per passenger (\$2,400 in total) to such international airfare charges. The Sponsor reserves the right to substitute the prize with a prize of comparable value if necessary. The Winner must claim their prize no later than November 17, 2018; Tour must be booked with Exodus Travels by May 1, 2019, and all travel must be completed no later than November 15, 2019. If the Winner is unable to travel by the date indicated, the prize will be forfeited. Other Conditions may apply. TRAVEL INSURANCE IS NOT INCLUDED AS PART OF THE PRIZE. **HOW TO ENTER:** Qualified Bike To Work BC participants who have logged at least one qualified bicycle trip (*a qualified bicycle trip includes any trip that one chooses to use a bicycle instead of drive a vehicle*) during Bike to Work Week can enter by visiting <https://www.exodustravels.com/win-cycling-adventure-italy> (the "Web Site") during the Promotion Period and completely fill out all the required fields on the entry form, including first and last name, complete home mailing address (no P.O. Boxes), date of birth and e-mail address. Then submit your entry form to the Web Site (the "Entry" or "Entries")." **Contest starts at 12:00 am Eastern Time ("ET") on October 1st and ends at 11:59 pm on November 15, 2018.** Limit one (1) Entry per person per e-mail address throughout the Promotion Period. Entries by the same person in excess of the limits stated herein will be disqualified. Entries submitted to the Web Site will be deemed to have been submitted by the authorized account holder of the e-mail address submitted at the time of the entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
